**II. Purpose of Addendum**

To modify the age range of residents served from 45 – 99 years of age, to 18- 99 years of age.

**III. Methodology**

On 3/18/24 I received a *Request For Modification Of The Terms Of The Registration/License* form from co-licensee designee, Achal Patel, dated 3/18/24. This modification request identified that Mr. Patel would like to update the age of residents the facility is able to serve from 45-99, to 18-99 years of age.

**IV. Description of Findings and Conclusions**

The facility is currently licensed to care for resident population types including physically handicapped, aged, and Alzheimer’s populations. The request to lower the age range to allow the facility to accept any adult 18 years of age and older would be appropriate given the current populations served at the facility. The co-licensee designees, Mr. Patel & Vivek Thakore are aware that they are responsible to ensure that all residents admitted to the facility have been properly assessed and determined to be compatible with other residents of the facility.

**V. Recommendation**

I recommend modifying the terms of the license to update the age of residents capable of being served at the facility from 45-99 years of age to 18-99 years of age.


