III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Physical Description of Facility

This adult camp is held at Grace Bentley (SR740200224), on the shores of Lake Huron on a 3.9 acre parcel property. The site includes camper cabins with bathrooms, a health care cabin, shower house, craft and activity building and dining hall. The high adventure program areas include swimming at pool and wading at waterfront. The facility is located in St. Clair County and approximately 12 miles from a McLaren Port Huron-Emergency Department. The camp is suitable to host this adult camp program.

B. Program Description

The adult camp serves campers aged 18 and older. The campers are enrolled in weeklong programs (Sunday to Friday) during the months of June through August. The daily activity schedule includes a rotation of activities including swimming, team sports, dances, bonfires, talent shows, arts and crafts, and carnivals. Campers are supervised by adult staff within acceptable ratios. Three meals are provided through the camp day. Staff are trained in behavior management, adult protection, emergency procedures, and health and safety procedures. The camp meets applicable licensing rules per the onsite inspection on 04/29/204 and records review.

C. Rule/Statutory Violations

The camp is in compliance with all applicable rules.

IV. RECOMMENDATION

I recommend issuance of an adult camp license with a capacity of 56 campers.


