II. Purpose of Addendum

The purpose of the addendum is to decrease the age range from 55 years of age to 18 years of age and to add the population mental illness.

III. Methodology

On 07/15/2024, I received a written request from the licensee designee Michael Mwathi requesting to decrease the age range to 18 years old and add the program type mental illness.

On 08/13/2024, I received the updated program statement, admission/discharge policy, from licensee designee Michael Mwathi. Within the program statement, Mr. Mwathi stated that this group home will conduct comprehensive assessment plans prior to admitting residents to ensure compatibilities with other residents.


On 08/15/2024, I reviewed current license file, licensee information in BITS, training documentation, experience and education of the licensee designee, revised program statement, and admission/discharge policy.

IV. Description of Findings and Conclusions

Based on the information received and documents reviewed, the licensee designee Michael Mwathi meets the requirements to provide services to mentally ill adults. Michael Mwathi, the licensee designee has a nursing administration degree with several years of experience working with individuals with mental illness. He is currently involved in scheduling their mental health appointments, medication management, therapy and behavioral techniques. Mr. Mwathi possesses the training and qualifications required to provide services to mentally ill adults.

V. Recommendation

I recommend that the age range be decreased to 18 years old and that mentally ill be added to the program type of Canfield Care Manor.


