ALLEGATION:

Resident B is not involved in the development of the service plan.

INVESTIGATION:

On 07/02/2024, Long-Term-Care State Licensing Section Manager Andrea Moore interviewed the complainant by telephone. The complainant alleged Resident B is not involved in the development of the service plan.

On 07/08/2024, Ms. Moore and this licensing consultant interviewed administrator Evonne White at the facility. Ms. White reported Resident B admitted to the facility on 12/05/2022. Ms. White reported she developed Resident B's service plan. Ms. White reported Resident B, Relative B2, and Relative B3 were present during the development of the service plan. Ms. White reported there was no documentation nor signature of Resident B participation in this meeting. Ms. White reported there have been updates to Resident B's service plan and Resident B has participated in the care conferences. Ms. White reported Resident B's service plan was updated in May 2024, to reflect Relative B1's not being able to visit due to physician order that the visits are medically contraindicated. Ms. White reported Resident B was not present during this update because the facility did not want to upset Resident B due to his medical fragile state. Ms. White reported Resident B's active durable power of attorney (DPOA) was made aware of the changes. Ms. White reported Resident B has not asked for Relative B1 to visit nor request to communicate with Relative B1. Ms. White reported overall Resident B is happy and has no concerns with the care

or lack of communications. Ms. White reported the facility plans to conduct an audit of all resident service plans to ensure there is documentation of resident participation in the development of their service plan.

I reviewed Resident B's service plans. Resident B had a service plan developed on 01/23/2023, 06/27/2023, 11/15/2023, 05/10/2024. I reviewed care conference note for care conference held on 11/21/2023. There was no documentation that Resident B participated in the development of these service plans.

ANALYSIS:	Interviews conducted and review of documentation revealed the facility could not provide evidence that Resident B participated in the development of the service plan.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, I recommend no change in the status of the license.
