II. Purpose of Addendum

Mr. Ganton requested to decrease the capacity of the home for the aged (HFA) by eliminating 9 beds from rooms numbered 2, 9, 14, 17, 20, 29, 44, 49, and room M. Mr. Ganton requested to change the number of assisted living beds from 94 beds to a total of 85 beds for the facility.

III. Methodology

On 8/29/2024, Mr. Ganton applied to decrease from 94 licensed beds to 85 licensed beds. On 9/5/2024, the Health Facilities Engineering Section room sheets were reviewed for the rooms identified to have a decrease in beds.

IV. Description of Findings and Conclusions

I reviewed HFES room sheets and determined rooms numbered 2, 9, 14, 17, 20, 29, 44, 49, and room M are one licensed bed with 420 sq ft, built in closets, and connected bathrooms. Day/dining space is adequate to support this decrease of 9 licensed beds.

V. Recommendation

It is recommended the license capacity decrease to reflect 85 licensed beds.
