ALLEGATION: Resident A is not supervised properly because she disturbs the neighbors when she screams and yells while outside.

INVESTIGATION:

On 8/6/2024, I received this complaint through the Bureau of Community and Health Systems (BCHS) online compliant system. This complaint alleged Resident A is not supervised properly because she disturbs the neighbors when she screams and yells while outside.

On 8/7/2024, I conducted an interview with Complainant who stated that he lives in proximity of the facility and often hears Resident A making loud noises and singing

while outside which is disturbing as this occurs early in the morning and throughout the day. Complainant stated he does not believe staff members are outside with Resident A which is why he believes Resident A is not being properly supervised.

On 8/7/2024, I conducted interviews with licensee designee Felicia Evans and staff member Sara Gue who both stated that Resident A often enjoys sitting outside in a chair and will sing songs especially if she has just watched a movie like the Disney movie, *"Let It Snow"*. In addition, these staff members stated Resident A is allowed to be outside on the property without staff's supervision as she does not have any issues with elopement. Felicia Evans stated she has received complaints from neighbors in the past regarding how loud Resident A sings however Felicia Evans has tried to communicate to the neighbors that Resident A has not demonstrated any form of aggression while outside and her singing is simply an activity that she enjoys doing. Felicia Evans stated they added a fence to the backyard to make sure residents were not going over to the neighbor's property. Felicia Evans stated there has not been any issues with residents trespassing and all the residents including Resident A don't have any issues with staying on the facility's property.

On 8/12/2024, I conducted an onsite investigation at the facility with direct care staff members Nikaterra Smith and Amber McPherson who both stated Resident A goes outside multiple times every day throughout the day and will sit in a chair in the driveway or on the porch without staff supervision per her *Behavioral Treatment Plan* (BTP). Nikaterra Smith and Amber McPherson also both stated Resident A usually stays outside for no more than 15 minutes each time and likes to sing songs loudly even when she is prompted to quiet down by staff members. Nikaterra Smith and Amber McPherson stated they have not had any complaints made directly to them about Resident A being a disturbance while outside and does not believe Resident A is a threat or is being malicious when she sings while outside the facility. It should be noted Resident A was not home at the time of my onsite investigation and therefore was not interviewed or observed.

While at the facility, I reviewed Resident A's *Behavioral Treatment Plan.* According to this plan Resident A is unable to move independently in the community and needs staff available to her while in the community however Resident A does have freedom of movement in the facility's yard without staff present.

APPLICABLE RULE	
R 400.14305	Resident protection.
	(3) A resident shall be treated with dignity and his or her personal needs, including protection and safety, shall be attended to at all times in accordance with the provisions of the act.

ANALYSIS:	Based on my investigation which included interviews with Complainant, licensee designee Felicia Evans, direct care staff members Sara Gue, Nikaterra Smith, and Amber McPherson along with a review of Resident A's <i>Behavioral Treatment Plan</i> , there was no evidence to support the allegation that Resident A is not supervised properly because she disturbs the neighbors when she screams and yells while outside. Felicia Evans, Sara Gue, Nikaterra Smith, and Amber McPherson all stated that Resident A routinely goes outside throughout the day and will sing songs loudly while on the premises of the facility however is not harmful or a threat to anyone in any way. These staff members further stated Resident A is not required to have staff supervision while outside at the facility. I reviewed Resident A's <i>Behavioral Treatment Plan</i> which stated that Resident A has freedom of movement in the facility's yard without staff being present therefore Resident A's supervision and protection needs are attended to at all times.
CONCLUSION:	VIOLATION NOT ESTABLISHED

ALLEGATION: Trash and debris are regularly observed in the facility's yard.

INVESTIGATION:

This complaint also alleged that trash and debris are regularly observed in the facility's yard.

On 8/7/2024, I conducted an interview with Complainant who stated that trash and debris is often blown in Complainant's yard from the facility's yard when it is windy outside. Complainant stated this is a routine occurrence.

On 8/7/2024, I conducted interviews with licensee designee Felicia Evans and staff member Sara Gue who stated that they have not seen trash and debris in the facility's yard and have not heard of any complaints made to them regarding the yard not being properly maintained.

On 8/12/2024, I conducted an onsite investigation at the facility with staff members Nikaterra Smith and Amber McPherson who both stated that cigarette butts are often thrown in the yard by Resident B because she sits outside all day and smoke cigarettes. Nikaterra Smith and Amber McPherson also both stated at the end of each shift, which consist of three different timeframes, staff members clean the yard area where the cigarette butts are often thrown. Nikaterra Smith stated she has put small garbage cans on the porch area to encourage Resident B to throw her cigarettes in the trash can however Resident B continues to throw them in the yard area. Amber McPherson stated Resident B smokes rapidly daily throughout the day and she finds it to be difficult to ensure the yard is litter free when Resident B constantly throws cigarette butts in the yard.

While at the facility, I also observed Resident B in the garage who refused to be interviewed. I observed Resident B smoking cigarettes while sitting in a chair with multiple cigarette butts on the ground where she was seated.

I also observed multiple cigarettes butts in three different areas in the yard specifically near the porch and garage.

ANALYSIS:	Based on my investigation which included interviews the complainant, licensee designee Felicia Evans, staff members Lauren Steveson, Sara Gue, Nikaterra Smith, Amber McPherson and inspection of the facility there is evidence that trash and debris are regularly observed in the facility's yard. The complainant stated trash and debris is blown in his yard from the facility's yard when it is windy outside and this is a routine occurrence. Nikaterra Smith and Amber McPherson both stated that cigarette butts are often thrown in the facility's yard by Resident B because she sits outside and smokes. Nikaterra Smith and Amber McPherson further stated despite cleaning the yard after each shift which occurs three different timeframes, Resident B consistently and continues to put cigarette butts on the premises in the yard area. During my onsite investigation, I observed trash in various areas of the yard. Staff members have failed to maintain the premises of the yard area so it is free from all hazards, nuisances and litter.	
CONCLUSION:	VIOLATION ESTABLISHED	

On 8/21/2024, I conducted an exit conference with licensee designee Felicia Evans. I informed Felicia Evans of my findings and allowed her an opportunity to ask questions and make comments.

On 8/21/2024, I received an approved an acceptable corrective action plan.

IV. RECOMMENDATION

An acceptable corrective action plan was approved therefore I recommend the current license remain unchanged.
