## III. METHODOLOGY

The complainant alleged residents have fallen, and the falls are not reported. This was investigated under SIR 2025A1021001 and SIR 2025A1021002.

#### ALLEGATION:

#### Food in memory care is not cooked.

#### **INVESTIGATION:**

On 09/19/2024, the licensing department received a complaint from Adult Protective Services (APS) with allegations the food in memory care is not cooked.

APS declined investigation of these allegations.

On 09/30/2024, I interviewed staff person 3 (SP3) at the facility. SP3 reported the food is not properly cooked at the facility. SP3 reported the food temperatures are not taken prior to serving the residents. SP3 reported the care staff are responsible for serving the food.

On 10/09/2024, I interviewed SP5 by telephone. SP5 reported there have been times meat is still pink and is not cooked. SP5 reported often the memory care unit

does not receive significant food and additional food must be requested from upstairs.

On 10/10/2024, I interviewed SP1 at the facility. SP1 reported all food is cooked in the assisted living unit. SP1 reported after the food is cooked, the temperature is taken, and the food is transported to the memory care unit in hot boxes. SP1 reported the memory care unit has steam tables to keep the food warm. SP1 reported memory care is responsible for plating and serving the food. SP1 reported typically the food temperature is taken prior to placing the food in the hot boxes.

On 10/10/2024, I interviewed SP2 and SP4 at the facility. SP2 and SP4 reported kitchen managers do not take the food temperature once the food is brought to the memory care unit. SP2 and SP4 reported the water temperature in the steam table is not taken. SP2 and SP4 reported at times the unit does not receive enough food for the residents.

On 10/10/2024, I reviewed the food temperature log located in the memory care unit. The log revealed some food temperatures taken by the kitchen department by the log was not consistent with food temperatures taken for every meal.

APPLICABLE RULE	
R 325.1976	Kitchen and dietary.
	(6) Food and drink used in the home shall be clean and wholesome and shall be manufactured, handled, stored, prepared, transported, and served so as to be safe for human consumption.
ANALYSIS:	The facility was unable to demonstrate that food is handled, stored, prepared, and transported safely for human consumption by not appropriately taking and recording the temperature of the food.
CONCLUSION:	VIOLATION ESTABLISHED

# IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, I recommend no change in the status of this license.
