II. METHODOLOGY

ALLEGATION:

An employee's children verbally abused residents.

INVESTIGATION:

On 10/10/24, I interviewed employee Hoy Wilson in the facility. Mr. Wilson stated that employee Amanda Cilley's children do not stop by very often. He advised that he had not seen them in over three months. He reported that he was aware that the children had been abusive toward residents in the past but because Ms. Cilley no longer works primarily at the facility, the children do not stop by.

I interviewed Resident A in the facility. Resident A denied interacting with Ms. Cilley's children.

I interviewed Resident B in the facility. Resident B denied any negative interactions recently. He provided the names of the children and recounted that for the most part,

he enjoyed their company when they stopped by. He stated that he had not seen them in a while but did not specify a timeline.

I interviewed Resident C in the facility. Resident C denied that the children come to the home and verbally abuse the residents.

On 10/22/24, I interviewed employee Amanda Cilley at On the Hill AFC. Ms. Cilley advised that she is the live in employee at this facility and no longer has regular shifts at McAnally's. She advised that after an investigation at McAnally's revealed that one of her children had injured a resident, that the children did not go there. She advised that they have not been there for over a month. She stated that there have been times where the children were at a nearby park and would stop by outside the facility to enable wifi-calling, so that they could call home for a ride.

APPLICABLE RULE	
R 400.14305	Resident protection.
	(3) A resident shall be treated with dignity and his or her personal needs, including protection and safety, shall be attended to at all times in accordance with the provisions of the act.
ANALYSIS:	Based on interviews with employees and residents, Ms. Cilley's children have not been in the facility for some time and three residents denied being verbally abused by the children or interacting with them recently. As such, there is insufficient evidence to establish a violation, that the residents are not being protected.
CONCLUSION:	VIOLATION NOT ESTABLISHED

On 11/14/24, I conducted an exit conference with licensee designee Vicky Cates. I shared my findings, and Ms. Cates agreed with the conclusions reached.

III. RECOMMENDATION

I recommend no change to the status of this license.


