ALLEGATION:

Staff smoke marijuana while on duty.

INVESTIGATION:

On 10/25/24, I conducted an unannounced onsite inspection at the facility. I interviewed the home supervisor Emma Dubiel. Ms. Dubiel stated she is not aware of direct care staff smoking marijuana while on duty. Ms. Dubiel did not appear under the influence herself. Ms. Dubiel stated a few of the staff smoke cigarettes but do not smoke marijuana.

On 10/25/24, while at the facility I interviewed direct care staff (DCS) Katelyn Plank. Ms. Plank stated she does not know of any staff smoking marijuana. Ms. Plank stated she does not smoke marijuana. Ms. Plank did not appear under the influence herself.

On 10/25/24, while at the facility I interviewed Resident A. Resident A stated she has not seen or smelled any of the staff smoking. She stated none of the staff ever appear under the influence. Resident A stated she has no concerns about the staff in the facility.

On 10/25/24, while at the facility I interviewed Hospice of Michigan staff Joseph Serrano. Mr. Serrano stated he has never witnessed any staff in the facility appear to be under the influence of drugs. He stated he has never smelled any of the staff smoking marijuana. Mr. Serrano stated he had no concerns with the staff.

On 10/25/24, I was contacted by the licensee designee Megan Charboneau by telephone. Ms. Charboneau stated she is not aware of any of her staff smoking marijuana while on duty. Ms. Charboneau stated she would not allow that to occur if she was aware of that.

On 11/7/24, I conducted another unannounced onsite inspection at the facility. I interviewed DCS Steve MacLedd. Mr. MacLedd stated he does not smoke marijuana, and he is not aware of any other staff smoking marijuana at the facility. Mr. MacLedd did not appear under the influence.

On 11/7/24, while at the facility I interviewed home supervisor Emma Dubiel. Ms. Dubiel again denied smoking marijuana and stated she is not aware of any other staff smoking marijuana at the facility. Ms. Dubiel did not appear under the influence.

On 11/7/24, while at the facility I interviewed Resident B. Resident B stated the staff provide good care and she has never smelled anyone smoking anything.
