### III. METHODOLOGY

12/11/2024	Special Investigation Intake 2025A0779013

#### ALLEGATION:

Staff tease and say inappropriate comments to residents. Staff Fatima Evans tells the residents they stink. Staff Courtney Diawara teases Resident A and Resident B about being boyfriends.

### **INVESTIGATION:**

On 12/2/2024, a phone conversation took place with recipient rights investigator, Pat Shepard, who confirmed that she was investigating the same allegations. ORR Shepard stated that she had spoken to Resident A, who confirmed the allegations. ORR Shepard stated that Resident A did not provide any further details.

On 12/18/2024, an on-site inspection was conducted and Resident C was interviewed. Resident C stated that he has never heard staff Courtney Diawara tease Resident A or Resident B about being boyfriends. Resident A stated that he has not heard Staff Diawara tease anyone and that he has no problem with her. Resident C reported that staff Fatima Evans does tell residents that they stink, are funky, and need to take a shower. Resident C stated that he has witnessed Staff Evans walk past residents while putting her shirt up over her nose, as a way of saying that residents stink. Resident C stated that all the other staff at this home are nice and are good to them.

On 12/18/2024, staff person, Makeese Singelton, stated that no residents have complained to him about Staff Diawara or Staff Evans disrespecting them and that he has never witnessed either staff doing so. Staff Singleton stated that a few months ago, it did come out that Resident A and Resident B may have had a sexual relationship, so it was not a secret, but that Resident A was not happy about that.

On 12/23/2024, a second on-site inspection was conducted and multiple residents were interviewed. Resident B stated that Staff Evans is rude, tells them that they stink and need to take a shower. Resident B reported that about one month ago, Staff Evans got up in his face and was cussing at him. When asked about Staff Diawara, Resident B stated that Staff Diawara has teased him about being boyfriends with Resident A, but that it happened a while ago and that he cannot remember was she exactly said.

On 12/23/2024, Resident D confirmed that Staff Evans is rude and tells other residents that they stink. Resident D stated that he witnessed the incident where Staff Evans walked up on Resident B and was cussing at him. Resident D reported that Staff Evans can be very confrontational and say things like "I don't like you guys", when talking to residents. Resident D stated that Resident A and Resident B's relationship is not a secret, but that he has not heard Staff Diawara tease them about it.

On 12/23/2024, Resident E and Resident F both stated that Staff Evans is rude, can be mean, and does tell them that they stink. They both stated that they have not heard Staff Diawara tease Resident A or Resident B and that they like Staff Diawara.

On 12/23/2024, staff person, Phillip Parrish, stated that he has not witnessed Staff Diawara tease Resident A or Resident B about being boyfriends. Staff Parrish stated that he has heard Staff Evans tell multiple residents that they stink and need to take a shower. Staff Parrish stated that he was present to witness Staff Evans and Resident B get into a verbal argument and that Staff Evans did get into Resident B's personal space and cuss at Resident B.

On 12/23/2024, staff person, Fatima Evans, denied that she has ever cussed at or disrespected any resident. Staff Evans admitted that she has told the residents that they have an odor and need to shower but denied that she has ever used the word "stink" when trying to get them to take showers. Staff Evans claimed that she told Resident B and other residents that they need to stop disrespecting her but denied that she cusses at them or invades their personal space. Staff Evans stated that she has never heard Staff Diawara tease Resident A or Resident B about being boyfriends. Staff Evans reported that she has witnessed Resident B trying to talk to Staff Diawara about sexual stuff between him and Resident A.

On 12/23/2024, staff person, Courtney Diawara, denied that she has ever teased Resident A or Resident B about their relationship. Staff Diawara stated that Resident A and Resident B frequently come to her and want to talk about their issues between each other and she has had to tell them she is not comfortable talking to them about detailed sexual issues. Staff Diawara stated that she has heard Staff Evans tell residents they need to take a shower, but that she has not heard Staff Evans use the word "stink" when talking to residents.

On 1/3/2025, a phone interview was conducted with Resident A, who claimed that Staff Diawara has teased him about his relationship with Resident B. Resident A stated that Staff Diawara says things like "You 'all together" and keeps saying that they are together when they are not. Resident A stated that he is fine with Staff Diawara otherwise. When asked about Staff Evans, Resident A confirmed that Staff Evans tells all the residents that they stink, almost every time she works.

On 1/16/2025, an exit conference was held with licensee designee, Paula Barnes. LD Barnes stated that she was not aware of this being an issue and that she will provide training to this home's staff regarding dignity and respect issues. LD Barnes stated that Staff Evans will receive written disciplinary action for her disrespect of the residents.

Special Investigations #2023A0871006 dated 12/16/2022, #2023A0779035 dated 5/22/2023, and #2023A0779038 dated 6/1/2023 cited a violation of R 400.1308 (2)(f)(ii). During all three investigations and separate occurrences, a staff was found to have verbally abused a resident by cussing at them. Regarding all three situations, a corrective action plan was provided, which stated that the employment of the staff in question was terminated and the remaining staff at this home were provided with training.

ANALYSIS:	It was confirmed that staff person, Fatima Evans, has been disrespecting the residents of this home. All six residents of this home have stated that Staff Evans is rude and tells them that they stink and need to take a shower. There was sufficient evidence found to warrant violation of this rule.

ANALYSIS:	It was confirmed that on at least one occurrence, staff person, Fatima Evans, got into Resident B's personal space and was cussing at him. Resident B stated that Staff Evans did cuss at him. Resident D and staff person, Phillip Parrish, stated that they witnessed the verbal altercation between Resident B and	

	Staff Evans and confirmed that Staff Evans was cussing at Resident B. There was sufficient evidence found to warrant violation of this rule.
CONCLUSION:	REPEAT VIOLATION ESTABLISHED
