IV. Description of Findings and Conclusions

Healing Together LLC was originally licensed on 01/02/2025 to serve the aged, developmentally disabled, and physically handicapped populations to six residents. The licensee is now requesting to serve the mentally ill and developmentally disabled populations by obtaining a specialized certification.

The licensee designee, Yvon Mukunzi, submitted his resume at the time of licensure documenting his experience with the mentally ill and developmentally disabled populations. Since 2018, Yvon Mukunzi has a history of working with residents who have been diagnosed with developmental disabilities and/or mental illness as a group home caregiver, a home care aide, a certified nurse assistant, a nurse-psych tech, and most recently as a psychiatric registered nurse for a local crisis residential facility.

Yvon Mukunzi acknowledged an understanding of the specialized certification rules. He submitted his updated program statement for the facility to reflect serving the mentally ill and developmentally disabled populations. His program statement reflected following personalized care and support plans, providing mental health and behavioral support, assisting with daily living skills, engaging in social and recreational activities, coordinating health and wellness care, and involving family and community for enhanced social inclusion. Additionally, Yvon Mukunzi acknowledged an understanding the facility will participate in increased fire drills and the completion of evacuation scores.

V. Recommendation

I approve the licensee's request to serve the mentally ill and developmentally disabled populations by obtaining a specialized certification effective 02/11/2025.
