

ALLEGATION: Resident was assaulted by another resident in the home. Resident received stitches on his forehead above his eyebrow and by his hairline.

INVESTIGATION: On 01/23/2025, I completed an unannounced onsite inspection. I interviewed licensee designee, Onome Akise and Resident B. According to Mr. Akise, Resident A no longer resides in his facility. Mr. Akise indicated he was not at the facility when the incident occurred. He stated staff, Rachel Jannow worked that shift. I interviewed Resident B. According to Resident B he was watching TV and asked Resident A not to turn the station. He stated Resident A turned the station and pushed him two times. He stated they started fighting and someone called the police.

On 01/30/2025, I completed a telephone interview with staff, Rachel Jannow. She stated Resident B had been controlling the television and she asked him to share it and allow Resident A to watch the news. She stated she then left the front room and went to the kitchen to wash her hands. While in the kitchen she stated Resident A and B started fighting. Ms. Jannow stated she asked them to stop fighting and for Resident B to “let him go” because he is significantly larger in size than Resident A. Ms. Jannow stated she’s unsure how they stopped fighting or who called the police. She indicated she believed another resident called the police.

On 01/30/2025, I completed a telephone conference with Office of Recipient Rights, Eryn Sherman and Case Manager, Kimberly Goodson. Ms. Goodson stated Resident B has a long history of aggressive behaviors. She further stated Resident A is very mild and passive. She indicated Resident B is approximately 6’2 and 300 pounds while Resident A is approximately 5’5 and 125 pounds. Ms. Goodson stated Resident A has a low cognitive status, and she has never had him initiate an altercation. She stated often he avoids altercations. According to Ms. Sherman and Ms. Goodson, another resident called the police. Ms. Goodson stated Resident A was transported to another placement after being discharged from the hospital. Ms. Goodson stated Resident A received stitches to his forehead and above his eye.

On 02/12/2025, I completed a telephone interview with Resident A. He stated he was watching TV and Resident B pushed him. He stated he’s not sure why he pushed him or started fighting him. According to Resident A, staff was there but did not break up the fight. He stated Resident C broke up the fight and called police.

On 02/12/2025, I completed a telephone interview with Resident C. Resident C stated he’s unsure who started the fight. He stated he heard the commotion and went to the living room. When he arrived, he stated Resident B was “slanging him into the wall like a rag doll.” He stated Resident A’s eye was swollen and he was


bleeding. According to Resident C, Resident A tried to fight back but, Resident B was bigger than him and he couldn't fight. Resident A stated he called the police. He indicated staff, Ms. Rachael said, "don't fight" and that was all she did. Resident C stated he was able to stop the fight and had Resident A go outside with him until the police arrived. He indicated the police arrived quickly.

On 02/13/2025, I completed a telephone interview with licensee designee, Onome Akise. I informed him this complaint is being substantiated because staff, Rachel Jannow did not appropriately handle this situation. I informed him Resident C stopped the fight and called the police. All actions that should have been completed or attempted by staff. Mr. Onome stated he's unsure why she didn't call the police. He stated he has previously advised staff to call the police during altercations especially if blood is visible.

ANALYSIS:	<p>Staff Rachel Jannow did not appropriately handle an emergency that involved a physical altercation in the facility.</p> <p>During my interview with Ms. Jannow, she stated she asked Resident B to stop hitting Resident A. She indicated she is unsure how the fight concluded or who called the police to intervene.</p> <p>Resident C indicated Resident B was "slanging him into the wall like a rag doll", him being Resident A. Resident C stated he intervened, stopped the fight, called the police and took Resident A outside until the police arrived. Resident C stated staff Rachel Jannow said, "do not fight" and did nothing else.</p>
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon submission of an acceptable corrective action plan, I recommend the status of the license remain unchanged.
