ALLEGATION:

Licensee, Kimberly Bishop is not recording resident medications properly.

INVESTIGATION:

An APS referral was made.

The complainant was anonymous and therefore was not interviewed.

On 3/17/2025, I interviewed the facility licensee, Kimberly Bishop. I reviewed her resident medication record and found that resident medications have not been recorded since July 2024. She stated that she was having a friend help her

computerize the resident medication records, but it has not been done. She stated that she has not purchased the computer as yet. Finally, she acknowledged that she had no real excuse for not recording the resident medications.

APPLICABLE RULE	
R 400.1418	Resident medications.
	 (4) When a licensee or responsible person supervises the taking of medication by a resident, the licensee or responsible person shall comply with the following provisions: (a) Maintain a record as to the time and amount of any prescription medication given or applied. Records of prescription medication shall be maintained on file in the home for a period of not less than 2 years.
ANALYSIS:	Given the evidence and Kimberly Bishop's admission, she and/or the responsible person/staff person did not maintain a record as to the time and amount of any prescription medication given or applied.
CONCLUSION:	VIOLATION ESTABLISHED

ALLEGATION:

Licensee, Kimberly Bishop is not dispensing resident medications properly.

INVESTIGATION:

On 3/17/2025, as part of my interview with Kimberly Bishop, she denied ever giving a resident's medication to anyone else.

On 3/17/2025, I attempted to interview Residents A, B, and C. However, due to their cognitive impairment from dementia, they were unable to answer any questions related to this allegation.

On 3/17/2025, I conducted an exit conference with the licensee Kimberly Bishop.

APPLICABLE RULE	
R 400.1418	Resident medications.
	(4) When a licensee or responsible person supervises the
	taking of medication by a resident, the licensee or

	responsible person shall comply with the following provisions: (b) Not adjust or modify a resident's prescription medication without agreement and instructions from a physician or a pharmacist who has knowledge of the medical needs of the resident. A licensee shall record in writing any adjustments or modifications of a resident's prescription medication.
ANALYSIS:	Since there was no corroborating evidence to support the allegation in the form of eyewitnesses, and since the resident medication records were compromised and I found Kimberly Bishop to be credible, then she and the responsible person/staff did not adjust or modify a resident's prescription medication without agreement and instructions from a physician or a pharmacist who has knowledge of the medical needs of the resident. A licensee shall record in writing any adjustments or modifications of a resident's prescription medication.
CONCLUSION:	VIOLATION NOT ESTABLISHED

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, I recommend no changes in the license status.
