II. Purpose of Addendum

Umbrellex Behavioral Health Services, LLC is requesting a modification for an increase in total capacity from three residents to four residents and making bedroom #1, per floor plan, a double occupancy two resident bedroom, instead of a single-private resident bedroom.

III. Methodology

- 04/08/2025 Contact-Document Received- *Request For Modification Of The Terms Of The Registration/License, floor plan*
- 04/15/2025 Inspection Completed On-Site- Measured bedroom 11.8ft X 14.19ft, total 158.6 sq. ft

IV. Description of Findings and Conclusions

On April 08, 2025, a request for modification of the terms of the license was received from Bianca Wilson, Licensee Designee of Umbrellex Behavioral Health Services, LLC. This request asked for an increase in total capacity of residents from three resident to four residents. With this increase, bedroom #1, per floor plan on the left-hand side of the hallway, will become a double occupancy with two resident beds. On April 15, 2025, an onsite inspection was completed, and bedroom #1 was measure with a total capacity of 158.6 sq. ft, exceeding the minimum requirement of 130 sq. ft. for double occupancy, total resident beds two.

Per the Original Licensing Study Report, the living room, dining room and sitting room areas measure a total of 568 square feet of living space. This exceeds the minimum of 35 square feet per occupant requirements, even with the increase in capacity to four.

V. Recommendation

It is recommended that the request and modification of increase in capacity from three residents to four residents be approved and the bedroom #1, be approved for 2 total resident beds.
