II. Purpose of Addendum

Currently, Country Living Senior Care is licensed for individuals aged 60-99 and they would like to lower their age group to 55-99.

III. Methodology

On 03/25/2025, I received a phone call from administrator, Courtney Shafer inquiring about taking in residents who are younger than their approved age. Ms. Shafer stated that the facility received an admission request for an adult who met the requirements for adult foster home but was under their approved age limit. Information was shared with Ms. Shafer regarding the requirements to change the age range and the importance of also making sure that all residents are compatible with each other.

On 04/22/2025, I received a request to modify the terms of Country Living Senior Care via email. The request also included updated admission policies with the new age range listed. Licensee designee, Keristin Hetherington requested to modify the age range of Country Living Senior Care to ages 55-99.

IV. Description of Findings and Conclusions

On 04/21/2025, licensee Keristin Hetherington submitted a written request to have the license amended. Documentation was reviewed and approved to modify the terms to age range of 55-99.

V. Recommendation

I recommend that the license be amended to lower the age range to 55-99.
