IV. Description of Findings and Conclusions

The resident bedrooms at the Mada Home have the following dimensions:

Total Occupancy: 5

The living, dining, and sitting room areas measure a total of 325.8 square feet of living space. This exceeds the minimum of 35 square feet per occupant requirement.

The staffing pattern of the home is adequate and includes a minimum of 1 staff to 5 residents per shift.

V. Recommendation

I recommend the capacity of the Mada Home (AS630418558) be increased to five residents.
