#### **ALLEGATION:**

Resident medications were left unsecured.

#### INVESTIGATION:

On 6/4/25, I received a phone call from Riverwood case manager, Haley Lindsley. Ms. Lindsley reported some concerns with the facility as she was visiting one of her clients and noted that Resident A's medication was sitting out on the dining room table and could have been taken by one of the other residents. Ms. Lindsley reported she expressed concern for Resident A's medication being left out and that the homeowner should supervise the administration of all medications.

On 6/9/25, I interviewed Resident A at the facility. Resident A reported she has lived at the home since last year and likes the environment. Resident A reported she takes medications every day that are administered the homeowner, Nelima. Resident A reported that she cannot remember if her medications have ever been left unattended on the dining room table in the common area of the home.

On 6/9/25, I interviewed Nelima Hazra at the facility. Ms. Hazra acknowledged that she left Resident A's medications on the dining room table unattended last week because she had to get something in another part of the facility. Ms. Hazra also acknowledged that she should have made sure the medications were secured before leaving the area as she had been waiting for Resident A to come downstairs to take her morning medications. Ms. Hazra was informed that the facility will be cited for not safeguarding Resident A's medication and signed on on-site corrective action plan.

APPLICABLE RULE		
R 400.1418	Resident medications.	
	(6) A licensee shall take reasonable precautions to insure that prescription medication is not used by a person other than the resident for whom the medication was prescribed.	
ANALYSIS:	It was alleged that resident medications were left unsecured. Based on interviews and the admission of the homeowner, Nelima Hazra this violation will be established. Ms. Nelima acknowledged that she left Resident A's morning medications in a common area of the facility unattended. A corrective action plan was obtained on-site and Ms. Hazra agreed to supervise the administration of all resident medications.	
CONCLUSION:	VIOLATION ESTABLISHED	

On 6/9/25, I shared the findings of my investigation with Nelima Hazra on site. Ms. Hazra acknowledged and agreed with the findings.
