## **II. Purpose of Addendum**

Currently, Ide AFC Home LLC is licensed for individuals aged 45-99 and they would like to lower their age group to 18-99, as there is a need in Livingston County to service a younger population with mentally ill diagnoses.

## **III. Methodology**

On 07/28/2025, licensee designee, Belinda Ide sent an email requesting information on how to lower her age range to 18-99 due to a need from Community Mental Health in Livingston County.

On 07/31/2025, I spoke with Belinda Ide via phone regarding her request. Ms. Ide confirmed that all individuals would be screened prior to placement to make sure they are an appropriate fit for the AFC home and are also compatible with other residents within the home. An updated program statement reflecting the new age ranges was also requested from Ms. Ide. Licensee designee, Belinda Ide requested to modify the age range of Ide AFC Home LLC to ages 18-99.

## **IV. Description of Findings and Conclusions**

On 07/28/2025, licensee designee Belinda Ide submitted a written request to have the license amended. Documentation was reviewed and approved to modify the terms to age range of 18-99.

## **V. Recommendation**

I recommend that the license be amended to lower the age range to 18-99.
