II. Purpose of Addendum

The purpose of the addendum is to add the mentally ill population to the program type for Caring Professionals AFC Group Home.

III. Methodology

09/11/2025- I received an email from licensee designee, Amitkumar Kalasariya, indicating he wanted to add the mentally ill population to his program type.

09/11/2025- I received an email containing a revised program statement, and admission statement. I also received a resume for the licensee designee, Amitkumar Kalasariya, outlining his experience with the mentally ill population.

09/15/2025- I reviewed the current license file, licensee's experience, licensee's information in BITS, the revised program statement, and admission policy.

IV. Description of Findings and Conclusions

Based on the information received and documents reviewed, the licensee designee, Amitkumar Kalasariya, is qualified to provide services to the mentally ill population. Mr. Kalasariya earned his bachelor's degree in physical therapy in 2005 and his master's degree in kinesiology in 2012. He has worked as a physical therapist in skilled nursing homes since 2013. Mr. Kalasariya has trained caregivers to recognize and respond to psychotic behaviors, ensuring safety. Furthermore, Mr. Kalasariya guides caregivers in using behavioral cues, consulting physicians for medication adjustments, and applying therapeutic strategies.

Mr. Kalasariya will conduct a thorough assessment prior to accepting residents into the home to ensure they are compatible with the other residents at Caring Professionals AFC Group Home.

V. Recommendation

I recommend that mentally ill be added to the program type of Caring Professionals AFC Group Home.


