This home has added an addition to the home. The addition consists of a dining room, kitchenette/utility area, three resident bedrooms and one full bath. Bedrooms #4 and #5 both have attached full baths, which now gives this home a total of 6 full baths. This addition has added two new entrance/exits, now giving this home a total of 4 entrances/exits, that are all at grade. The 3 additional resident bedrooms and dining room measured as follows:
