**ALLEGATION:**

**On 2/04/2026, this facility received a fire inspection disapproval from the BFS.**

**INVESTIGATION:**

A fire inspection report was received on 02/04/2026 completed by Mauricio Barrera from the Bureau of fire services. The report documents that this facility received a disapproval rating following an inspection on 02/04/2026. The report documents the following;

“1 - Whenever or wherever any device, equipment, system, condition, arrangement, level or protection, fire –resistive construction, or any other feature is required for compliance with the provisions of this code shall thereafter be continuously maintained. 4.6.12.1

**INSPECTOR COMMENTS:**

> Fire alarm breaker missing breaker lock to prevent accidental shutoff. Add breaker lock.

2 - To ensure operational integrity, the fire alarm system shall have an approved maintenance and testing program complying with the applicable requirements of NFPA 70 and NFPA 72. 9.6.1.5

**INSPECTOR COMMENTS:** >Sensitivity testing required every 2 years. Submit sensitivity test report to the inspector at Barreram1@michigan.gov or have it done”.

A subsequent fire inspection report was received on 02/18/2026. The report documents that an acceptable corrective action was submitted by the licensee, and this facility now has an “A” rating.

An unannounced inspection of this facility was conducted on 03/12/2026. The facility records were reviewed. The facility records contain documentation from Sonitrol Inc. that corrections were made by an alarm technician on 02/17/2026. All alarm and pull stations were observed during this inspection and were found to be in good working order.

<b>APPLICABLE RULE</b>	
<b>R 400.647</b>	<b>Safety and maintenance of premises.</b>
	<b>(1) A facility must be constructed, arranged, and maintained to provide adequately for the health, safety, and well-being of occupants.</b>
<b>ANALYSIS:</b>	A fire inspection disapproval rating was received on 02/04/2026 from the Bureau of Fire services. A subsequent inspection report was received on 02/18/2026 stating that the deficiencies

	have been corrected and an "A" rating was given. The facility records document that the corrections were made on 02/17/2026 by a technician from Sonitrol Inc. Based on the documentation reviewed, it is determined that there was a violation of this rule and a corrective action plan will be requested.
<b>CONCLUSION:</b>	<b>VIOLATION ESTABLISHED</b>

An exit conference was conducted with Angela Work, program manager and designated representative, on 03/12/2026. The findings in this report were reviewed, and a corrective action plan was requested.

#### IV. RECOMMENDATION

I recommend that the status of this license remains unchanged with the receipt of an acceptable corrective action plan.


