IV. Description of Findings and Conclusions

On February 13, 2026, I received a text message from Licensee Designee Virtrina Johnson indicating they are adding resident bedrooms to the upstairs of the home over the garage. Licensee Designee Johnson requested an on-site inspection.

On February 17, 2026, I sent an email to Licensee Designee Johnson regarding the date the of on-site inspection.

On Febraury 19, 2026, an on-site inspection was completed.

On March 16, 2026, a second on-site inspection was completed with Manager Mary Holton and room measurements were completed. One resident bedroom with single occupancy will be added and this bedroom measures 13'7" x 10'9". The resident bedroom was noted to have non-locking against egress hardware. An office with be added and the measurements are 11'2" x 10'7". A game room will be added and measures 18'2" x 6'9".

On March 25, 2026, update floor plan and evacuation plan was received from Licensee Designee Johnson.

V. Recommendation

I recommend licensure of a fifth resident bedroom upstairs with single occupancy.
