ALLEGATION:

Resident A was mistreated by being in a relationship with an employee in 2026.

INVESTIGATION:

On 4/24/26, I received this complaint. I noted that I investigated identical allegations on complaint number AS460306622_SIR_2025A1032007. During the course of that investigation, Resident A was interviewed and denied the allegation, the police reportedly tried to interview him, and Ms. Rople had separated from the facility.

On 4/29/26, I left a voicemail for Resident A.

On 4/30/26, I interviewed Home Manager Michelle Sloan in the facility. Ms. Sloan stated that Alexis Rople left the company in September 2024. She advised that Resident A was discharged in 2025 but from her understanding, he is in a

psychiatric hospital. She reported that Ms. Rople has filed a restraining order against Resident A.

On 6/4/26, I received documentation that employee Alexis Rople was terminated from the facility on 9/21/24, after she found new employment.

APPLICABLE RULE	
R 400.681	Resident rights; licensee responsibilities.
	(1) A resident shall be treated with dignity and respect, free from exploitation, and protected and safe. (2)
ANALYSIS:	Considering Ms. Rople was terminated on 9/21/24, there is no evidence that she engaged in an inappropriate relationship in 2026 with Resident A. Resident A was reportedly discharged from the facility in 2025. It was noted that a similar complaint involving Resident A and Ms. Rople had been resolved with no findings. I was unable to interview Resident A for this report, as he had been discharged from the facility. I have no evidence or witnesses to establish that a violation occurred.
CONCLUSION:	VIOLATION NOT ESTABLISHED

On 6/5/26, I shared my findings with licensee designee Scott Brown, during an exit conference.

IV. RECOMMENDATION

I recommend no change to the status of this license


