III. METHODOLOGY

ALLEGATION:

Licensee Michael Brewer was disrespectful to Resident A.

INVESTIGATION:

On 7/31/26, I conducted an interview with the complainant who verified the information.

On 8/5/26, I conducted an unannounced investigation at the facility. Recipients' rights advisor (ORR) Melissa Leach was present for the interviews. I conducted an interview with licensee Micheal Brewer. Mr. Brewer stated he did not take Resident A's property nor was he disrespectful to Resident A. Mr. Brewer stated Resident A came home with the chewing device which Resident A stated was bought for him. Mr. Brewer stated he never called Resident A a dog nor did he tell him it was a dog's chew toy. Mr. Brewer stated Resident A still has the chewing devices as they are

used when he gets mad to calm him down. Mr. Brewer stated Resident A's case manager knows about the devices and supports Resident A having them.

On 8/5/26, I conducted an interview with household member Heather Yager. Ms. Yager provided a statement consistent with those made by Mr. Brewer.

On 8/5/26, I reviewed the health care appraisal, assessment plan and resident care agreement which had nothing against chewing devices. The documents verified Resident A's anger with biting, and the staff is required to redirect him during an episode.

On 8/6/26, ORR Melissa Leach conducted an interview with Resident A. Resident A provided a statement consistent with those made by Mr. Brewer and Ms. Yager.

APPLICABLE RULE	
R 400.681	Resident rights; licensee responsibilities.
	(1) A resident shall be treated with dignity and respect, free from exploitation, and protected and safe.
ANALYSIS:	Based on my investigation, interview with staff and Resident A. There is no corroborating evidence of staff being disrespectful to Resident A.
CONCLUSION:	VIOLATION NOT ESTABLISHED

IV. RECOMMENDATION

I recommend the status of the license to remain unchanged.

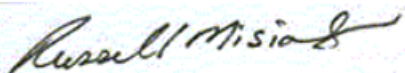
