II. Purpose of Addendum

The purpose of this addendum is to change the terms of the license by increasing the capacity of Andrews House CLF from five to six residents.

III. Methodology

On May 10, 2005, this licensing consultant conducted an on-site inspection of Andrews House CLF.

IV. Description of Findings and Conclusions

- A. The Northwest semi-private bedroom contained 183 square feet of space. The Southwest semi-private bedroom contained 178 square feet of space. The Southeast semi-private bedroom contained 172 square feet of space. The bedroom space in each bedroom at Andrews House CLF exceeded rule requirements. Each bedroom door measured 36 inches in width for wheelchair access. Each bedroom contained an easily openable window.
- B. The living room contained 284 square feet of space. The dining room contained 143 square feet of space. The combined square feet of space in these two common areas was 427 square feet of space or 71 square feet per occupant. The living and dining areas of Andrews House CLF exceeded rule requirements.
- C. The bedrooms at Andrews House CLF were furnished to comfortably accommodate six residents.
- D. Hard-wired smoke detectors and sprinklers were located in each bedroom.
- E. Emergency evacuation routes were posted in several places throughout Andrews House CLF. Exit signs were prominently posted above each exit.
- F. Andrews House CLF was equipped with fire extinguishers.

V. Recommendation

I recommend changing the terms of the license by increasing the capacity of Andrews House CLF from five to six residents.
