## **II. Purpose of Addendum**

The licensee sent a modification request to use an unoccupied bedroom for 2 additional residents. The modification request was for change of space and to increase capacity from 4 to 6 residents.

## **III. Methodology**

This consultant inspected the home on 10-3-2005 and the space was measured for capacity. The licensee was informed that the room must be furnished and ready for residents in order to change the capacity.

The home was inspected on 10-10-2005 and the room was furnished according to rule requirements. A new floor plan was submitted and the evacuation plan for the new use area was posted.

## **IV. Description of Findings and Conclusions**

The new bedroom is 13'6" x 13'2" and will accommodate two residents. The bedroom is fully furnished according to rule requirements. The living space is adequate to accommodate 2 additional residents.

## **V. Recommendation**

I recommend that the capacity of the home be changed from 4 to 6.
