II. Purpose of Addendum

Voluntary reduction in license capacity of the congregate facility from 40 to 21.

III. Methodology

4-4-06 – On-site inspection to review revised floor plan and to identify resident bedrooms

4-5-06 – Letter from Licensee Designee requesting reduction in capacity from 40 to 16 residents

4-6-06 – Telephone contact with Vice-President of Powell AFC Homes, Inc. advising 21 is the lowest congregate capacity option

4-7-06 – Letter from Vice-President of Powell AFC Homes, Inc. requesting reduction in capacity from 40 to 21

IV. Description of Findings and Conclusions

During the renewal inspection of 3-9-06 I identified 26 resident bedrooms that met the requirements for furnished bedrooms under the Licensing Rules for Adult Foster Care Congregate Facilities. After consultation with Mr. Ratzlaff, he decided to request a reduction in capacity to 16 for the facility. As this would have required a new Large Group Home license, a decision was made by the Vice-President to request a reduction in capacity to 21 beds.

I completed an inspection of the facility on 4-4-06 with Ken Ratzlaff, licensee designee/administrator, and the corporation Vice-President. The purpose of the inspection was to get an updated floor plan of the facility and to accurately identify the bedrooms designated for resident use.

Based upon the revised floor plan and identification of resident bedrooms, bedrooms 1-10 on the first floor and bedrooms 19-29 on the second floor are approved for single occupancy resident use.

The Department recognizes the licensee's right to increase the capacity to a maximum for 40 beds, once those bedrooms are appropriately furnished and inspected by the Office of Children and Adult Licensing to verify compliance.

V. Recommendation

It is recommended that the licensed capacity of The Oaks be reduced from 40 to 21 as part of the license renewal process.
