## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### A. Physical Description of Facility

The facility is a large ranch home located in a residential neighborhood. The facility has both public water and public sewer. It is not wheelchair accessible. There is 604 s.f. of living space. The bedrooms measure: 1) NE: 160 s.f.; 2) SE: 92 s.f.; 3) SE: 113 s.f.; 4) S: 104 s.f.; 5) SW: 137 s.f.; and 6) SW: 120 s.f.. The maximum capacity is 6 residents.

The licensee, Reach Foundation Inc, leases the home from Lazarus Management LLC.

The home has an interconnected fire detection system and is in compliance with fire safety rules.

### B. Program Description

#### 1. Administrative structure

The Reach Foundation Inc is the licensee for Welcome Home Ranch. The corporation has designated Edward Lark as the licensee designee and administrator.

## 2. Qualifications and competencies

The department has received an acceptable licensing record clearance, medical certification and TB test result on Edward Lark.

Mr. Lark meets the requirements of administrator. Mr. Lark has over 10 years of experience in adult foster care.

## 3. Program information

The licensee is certified to provide a specialized program for both MI and DD residents. The licensee also serves the TBI population. See program statement for details.

## C. Rule/Statutory Violations

There are no rule/statutory violations

## IV. RECOMMENDATION

I recommend issuance of a temporary license to this AFC adult small group home (capacity 1-6).


