**II. Purpose of Addendum**

The licensee designee/administrator requested a reduction of capacity from six to four residents.

**III. Methodology**


Jami Hays requested a reduction in capacity at the time a renewal inspection was being scheduled on 07/19/2006. She subsequently sent a letter dated 08/01/2006 to put this request in writing.

**IV. Description of Findings and Conclusions**

When an on-site inspection was made on 07/20/2006, the licensing consultant found that only four residents have consistently lived in the Deer Ridge Group Home that was originally licensed for a capacity of six. Each resident has her own bedroom and there are no additional beds or furnishings to accommodate more than four residents.

**V. Recommendation**

This licensing consultant recommends that capacity be reduced from six to four residents as requested.
