II. Purpose of Addendum

The purpose of this Addendum is to change the number of bedrooms that is licensed at Hunt Home. Licensee Designee Robert Fulton wishes to license a room that is currently used for the office.

III. Methodology

On 11/26/2007, this consultant provided telephone consultation to Licensee Designee Robert Fulton.

On 11/28/2007, an onsite inspection of Hunt Home was conducted and this consultant received a copy of the Modification Request to Change the Terms of the License.

On 11/28/2007, this consultant verified the measurement of the room, bedroom #4, that Licensee Designee Robert Fulton wishes to license. Bedroom #4 contained 173.95 square feet of space, more than ample space for one resident.

On 11/29/2007, this licensing consultant recommended a Change in the Terms of the License at Hunt Home.

IV. Description of Findings and Conclusions

On 11/26/2007, a Modification Request to Change the Terms of the license was requested by License Designee Robert Fulton.

On 11/28/2007, Licensee Designee Robert Fulton provided a floor plan of Hunt Home that indicated bedroom #1 will be licensed for two people; bedroom #2 will be licensed for one person; bedroom #3 will be licensed for two people, and bedroom #4 will be licensed for one person.

On 11/29/2007, a recommendation was made to Change the Terms of the License to license bedroom #4 for one person.

V. Recommendation

I recommend licensure for bedroom #4 for one person, and changing bedroom #2 to be licensed for one person.
