IV. Description of Findings and Conclusions

Per variance approval from Central Office, Bedroom #6, is approved for use as a single occupancy bedroom.

Bedroom #6 – (located central portion/ south wall of resident wing). 7' x 11" 2", plus 5' x 4'4" alcove, total sq. ft. = 100 sq. ft.

V. Recommendation

Approve Bedroom #6 for resident use as a single occupancy bedroom. (total six single occupancy bedrooms.)

Continue temporary license and certification, issued 12-01-07, capacity 6 (six) residents in need of adult foster care services.
