**II. Purpose of Addendum**

Increase the capacity of Blessed Home to 20 beds (increasing the capacity by one).

**III. Methodology**

The licensee informed me that he had made modifications to a room that previously did not have adequate floor space to be approved for a resident bedroom. The room was measured and inspected by this consultant on 10/25/2007.

Room dimensions are: 9' 3" x 9'7" = 88.6 sq. ft.

less (2'1" x 2' 1"= 04.3 sq. ft.)

Total Sq. Ft. = 84.

The bedroom meets the minimum requirements for floor space for 1 bed. The bedroom also contained the minimum requirements for furnishings and door hardware.

**IV. Description of Findings and Conclusions**

The facility has met the requirements for 20 beds. The capacity is changed from 19 residents to 20 residents.

**V. Recommendation**

Increase the capacity of Blessed Home from 19 residents to 20 residents.
