II. Purpose of Addendum

To increase capacity of this facility to six from five.

III. Methodology

03-06-2008 - Contact telephone call received/ Mrs. Berry.

03-12-2008 – Inspection completed on site.

IV. Description of Findings and Conclusions

Mrs. Berry contacted me to inspect a bedroom for the purpose of increasing the capacity of her adult foster care. To date, Mrs. Berry had two bedrooms dedicated to resident use. One bedroom is triple occupancy, or it houses three residents. A second bedroom is a double occupancy room, housing two residents.

Mrs. Berry has an additional bedroom that she will use to provide adult foster care services. This bedroom is located near her private bedroom in the northern section of her home. An additional bathroom, adjacent to this bedroom, will be opened to resident use, and is very convenient to the bedroom. The bedroom measures 9' 6" x 13' 2", or 125 sq. ft., approved for single occupancy. The additional bedroom is adequately furnished, clean and brightly painted.

Mrs. Berry will also open for resident use the private living room on the north side of the home. The living room, 13' 4" x 21', will add 280 sq. ft. of additional square footage for resident use. Mrs. Berry will also have an additional dining room added for resident use. This dining room, centrally located in the north side of her home, measures 10' 4" x 10', or 103 sq. ft. of additional general living space. A dining table with enough room for all residents of the home is available in this area.

The current resident living/ dining room is approximately 175 sq. ft. With the general living space noted above, there is 557 sq. ft. to meet the requirement noted in R 400.1427 (1) A licensee shall provide, per occupant, not less than 35 square feet of indoor living space, exclusive of bathrooms, storage areas, hallways, kitchen, and sleeping areas.

All applicable adult foster care rules are met for the bedroom and additional resident living room and dining room.

V. Recommendation

The capacity of this facility will be increased to six (6)
