#### III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### A. Physical Description of Facility

This is a one story brick and frame building in a residential subdivision. This home has an attached garage which is used only for storage. The heating plant and hot water heater are located on the main level behind a one hour enclosure that is kept locked.

This facility is wheel chair accessible and is designed to be handicapped accessible.

This home has a living room, kitchen, dining area, four bedrooms, two bathrooms, and laundry room. There is documentation on file that bedrooms and living space meet rule requirements for six residents.

The two resident bathrooms are located in the same hallway as the resident bedrooms, and accommodate wheelchairs and physically handicapped.

This facility has public water and sewage disposal systems. A leak in the plumbing has been repaired.

This home has an interconnected alarm system which was demonstrated to be working during the July 2 on-site inspection. The system was professionally inspected on June 16, 2008.

## **B. Program Description**

This facility will serve individuals with developmental disabilities and/or physical handicaps. Specialized programming is funded with contract monies from the Berrien Mental Health Authority. This facility has been licensed for this purpose since 1987; the new license represents a change in licensee.

This home is owned by a private individual and is leased on a month to month basis by Berrien Mental Health Authority. Berrien Mental Health then contracts with Spectrum Community Services to operate the home.

Spectrum Community Services is a non profit organization that has been in existence for a number of years and operates adult foster homes throughout the state. The primary office is located in Westland; a regional office is located in Benton Harbor. David Schnoor of the Benton Harbor office is license designee and administrator.

Because Spectrum Community Services has been in existence and has numerous other homes, the corporation has amply demonstrated administrative and financial capability and has established the qualifications of Mr. Schnoor.

This home will be staffed with three shifts, three staff on duty during resident awake hours, and two staff during hours of sleep. Some residents receive day programming inhouse, which is why a third staff person is available during awake hours.

Spectrum Community Services is aware of the requirements for resident care and employee and resident record keeping. The applicant is aware of the statutory requirements of PA 218, Section 400.734(b) concerning the hiring or contracting of persons who provide direct services to residents.

## C. Rule/Statutory Violations

The applicant was found to be in substantial compliance with the licensing act and applicable administrative rules during the July 2, 2008 on-site inspection.

#### IV. RECOMMENDATION

I recommend issuance of a temporary license to this AFC adult small group home (capacity 1-6).
