09/30/2008 – Increased capacity from two to three.

IV. Description of Findings and Conclusions

This consultant completed a renewal on-site inspection of the facility on September 22, 2008. The licensee informed this consultant that she may be interested in increasing the capacity of her license, if she was contacted to take another resident through Community Mental Health.

Resident Bedroom 2 measures 8 feet by 13 feet, for a total of 104 square feet. Bedroom 2's total capacity is 1 resident.

V. Recommendation

This consultant recommends this adult foster care family home license be increased to a capacity of three (3).
