II. Purpose of Addendum

Notification received from the Licensee Trinity Continuing Care Services indicated a change in the company's name.

Notification received from the Authorized Representative indicated a change in the home for the aged name.

III. Methodology

-A letter from Vice President of Planning Marketing and Public Relations for Trinity Continuing Care Services dated June 2, 2008, was submitted to the Department of Human Services requesting a name change of the company to Trinity Senior Living Communities. The Corporate ID and Federal Employer ID numbers were not changed. This represents a name change only, not a change of ownership. This change of licensee name was approved in a letter dated August 26, 2008, from the Division Director of Adult Foster Care and Home for the Aged Licensing, of the Bureau of Children and Adult Licensing, to the Vice President of Senior Housing Operations for Trinity Senior Living Communities.


