The purpose of this addendum to the original licensing study report is to increase capacity of the Bridget Johnson AFC from 4 residents to 5 residents.

III. Methodology

IV. Description of Findings and Conclusions

Review of the licensing file reflects that this facility has three resident bedrooms. Bedroom 1 measures 11.0 x 11.33"=124.6 sq ft. and is licensable for 1 resident. Bedroom 2 measures 11.33" x 11. 67"=132.2 sq. ft and is licensable for 2 residents. Bedroom 3 measures 14.1" x 15.11"= 237 sq ft. and is licensable for 2 residents.

V. Recommendation

I recommend the capacity of the Bridget Johnson AFC to be increased to 5 residents.
