## II. Purpose of Addendum

A letter dated 4/14/2009 from Beth Mell, Authorized Representative for Clare Bridge of Ann Arbor, a Brookdale Community, was received by the Department on 4/15/2009. The letter requests a modification of terms to the original license due to a recent legal entity name change for the licensee, Alterra Healthcare Corporation.

## III. Methodology


Beth Mell, Authorized Representative, sent a letter dated 4/14/2009 to the Adult Foster Care/Home for the Aged Division Director, Deborah Wood. The letter indicates that on February 17, 2009, Alterra Healthcare Corporation changed its name to Brookdale Senior Living Communities, Inc. This is only a change in the name of the legal entity. The tax identification number will remain the same. Enclosed with this letter is the Certificate of Amendment to the Amended and Restated Certificate of Incorporation of Alterra Healthcare Corporation as filed with the Delaware Secretary of State. Also enclosed is the required filing with the Michigan Department of Energy, Labor and Economic Growth updating the name of the legal entity.

## IV. Description of Findings and Conclusions

Upon request of Beth Mell, Authorized Representative for Clare Bridge of Ann Arbor, a Brookdale Community, the licensee name of Alterra Healthcare Corporation is to be changed in accordance with the current legal entity name of Brookdale Senior Living Communities, Inc. effect 2/17/2009.

## V. Recommendation

It is recommended that the facility's license is modified to reflect the licensee's legal entity name change effective 2/17/2009, from Alterra Healthcare Corporation to Brookdale Senior Living Communities, Inc.
